Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery following the COVID-19 pandemic, notably in its targeted support through the National Tutoring Programme for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Mobility of our disadvantaged pupils means that they often have gaps in prior learning – these are evident from Reception through to KS2
2	Assessments and observations suggest that disadvantaged pupils have greater difficulties with phonics than their peers. This negatively impacts on their development as readers. Discussions with pupils also highlights the lack of high- quality texts at home.
3	Internal and external assessments at KS1 indicate that maths attainment is below national and this includes the attainment of disadvantaged pupils.
4	Observations and discussions with pupils and families have identified social and emotional issues for many pupils as well as a lack of enrichment opportunities.
5	Our attendance data has improved over the last 12 months but remains lower for disadvantaged pupils. 85% of our persistent absentees were disadvantaged.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

To achieve and sustain improved wellbeing for all pupils in our school, particularly our disadvantaged pupils.	Sustained high levels of wellbeing by 2024/25 demonstrated by: qualitative data from student voice, student and parent surveys and teacher observations
To achieve and sustain improved attendance for all pupils, particularly our disadvantaged pupils	Sustained high attendance by 24/25 demonstrated by: The overall attendance to be in line with national figures or better. The percentage of all pupils who are persistently absent being below national figures. The figure among disadvantaged pupils being in line with non-disadvantaged children.

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

In addition to our maths scheme we have introduced mastering number throughout the school. This enables us to ensure that children have quick recall of arithmetic facts. Although 2 KS2 children did not reach ARE for maths progress was made and they reached standardised scores of 98 and 99.

A new SSP was introduced in school in 2022 throughout the school and all teachers trained, working with English Hub to ensure consistent standards and monitoring of the provision of phonics teaching. Nearly all children in Year 1 and those retaking the PSC passed. Focused interventions show progress.

Attendance figures were above national and the number of children arriving late and being absent for reasons other than illness were reduced. We had no persistent absentees of children still attending at

the end of the school year.
